Prospectus

Submission is open to photographers - amateur, professional. The juror will take into account the following criteria: creativity, photographic style, narrative, image composition, lighting, degree of difficulty, and emotional impact. All subjects and styles, color and B&W, will be considered.

Our juror is photographer Jay B. Wilson.

Based in Greenwich, CT, Jay B. Wilson has worked as a fine art photographer since 2003. His focus is on documenting the beauty of Connecticut’s Gold Coast and New York City, as well as his travels across the United States and around the globe. In his photography, Wilson is drawn to tall buildings, lush landscapes, and salt water.

Wilson’s photography has been exhibited recently at institutions such as the Carriage Barn Arts Center, Greenwich Art Society, Greenwich Historical Society, and Rowayton Arts Center. His work is in private collections around the country, as well as corporate collections at the New York Hilton and Andaz Fifth Avenue Hotel. Wilson has staged solo shows in Westchester County and New York City, including two exhibitions at Google’s New York headquarters.

Wilson’s work has also been featured in Popular Photography, Greenwich Magazine, Fourculture Magazine, the Manhattan User’s Guide, and Photogrunt. He is an exhibiting member of the Rowayton Arts Center, The Carriage Barn Arts Center, and the Greenwich Art Society. He has served as a judge for the Stamford Photography Club for nearly 10 years.

Submission Guidelines

Open call for all photographers. (Professional - amateur)

Nude subjects are allowed at the discretion of the selection committee.

Maximum width for photography is 48" before framing.

IMPORTANT: All artwork must be wired before delivery

Gallery-wrap canvas, metal and acrylic plexiglass without additional frame are permissible but must be **securely wired for hanging**.

No saw-toothed hangers.

Works for sale are encouraged.

Please note that all sales made during or as a result of this exhibit are subject to a 20% commission payable to the LAA.

Loft Artist members: \$25 for first , \$10 each additional

Non-members: \$30 for first, \$10 each additional

Maximum number of entries 5 per artist.

MULTIPLE ENTRIES must be made at the same time on EntryThingy to receive discount.

Entry fees help support the activities of our non-profit organization.

LAA Members will enter a discount code when checking out.

All submissions are to be made online with high-quality digital images through EntryThingy. A free account is required to upload photos; however EntryThingy membership is not required.

Minimum image width: 600 pix

Entry gives your consent for selected works to be included in promotional materials printed and online. Please select the ok to publish option when submitting your entry or we will be unable to consider your artwork for the show.

Delivery of Artwork

All selected art must be delivered unpacked and ready to hang or display. Juror and curators reserve the right to reject any selected work upon delivery if it appears substantially misrepresented by the submitted image. Works should be delivered to the Loft Artist Association at 575 Pacific Street, Stamford, CT 2nd Floor

Loft Artists Association will not be responsible for unpacking or re-shipping. A local shipping & handling service is available through The Packaging Store in Stamford.* (Details below). Or you can choose one of your own.
